# Aims of the Association

We work with Heads/Principals from 690 of the best accredited schools and colleges across the UK and beyond in order to provide fellowship and support in promoting excellence in education.

We aim to:

- Sustain our schools by providing high-quality information and advice (from HQ, Area Co-ordinators, consultants and other professionals)
- Promote Members' support networks and fellowship regionally, nationally and internationally
- Provide extensive enrichment opportunities for pupils in Area and National Competitions for Sport, Drama and the Arts
- Arrange conferences and professional development courses to promote excellence in independent education
- Promote initiatives and provide access to a wide range of member services, such as free legal advice and low-cost procurement
- Influence the national educational debate by promoting independence and choice

# Our Values

ISA values the diversity of our schools, which cover the complete age range and vary in size and nature, from charitable trusts to proprietorial schools, early years to senior, boarding and day schools, all-through schools, co-educational and single gender, and specialist schools and colleges in the arts, special needs and music.

We exist to serve all of our schools so that they can enhance the educational experience of all pupils in their care and ensure that their pupils go on to enjoy success and lead fulfilling lives.

# Types of Membership

ISA is one of the sponsoring associations of the Independent Schools Council (ISC, a federation of associations which exist to promote independent education. ISC represents over 1,400 of the independent schools and colleges in the UK (around 75% of the total number, together educating more than 600,000 pupils.

The four main types of ISA Membership/Affiliation are:

## Full

For Heads or Principals who wish to work with the Association to promote excellence in their schools. Heads elected to Full Membership are subject to the Articles that govern the Association, have voting rights and may present for honorary office. Their schools have access to a range of ISA services, including Area and national sports and competitions. Members' schools are also granted access to ISC, ISI and IStip (for teacher induction).

## Associate

(including Head/Principal/CEO of group, school, life and former member)

For those who have (or have had) management or leadership responsibility within an independent school where there is already a full ISA Member.

## Affiliate

(including UK, overseas and group)

For Heads or Principals who do not meet all the requirements for full membership of the Association, but who would benefit from links with it and who would enrich the Association.

## Dual

For Heads or Principals who recognise that belonging to ISA as well as an additional Heads' Association will offer something complementary – be it the professional development, the extra-curricular opportunities in sport, art and drama, or the additional layer of support, networking and services. Dual Members have the same rights as Full Members.

Full and Dual Membership Schools are able to display the ISA Accredited Schools Plaque and use the ISA logo on communications, including their website. Affiliate ISA Schools may display the ISA Affiliate Plaque and appropriate logo.

## ISA Support

## Legal advice



ISA membership gives you a free initial legal advice line from Penningtons Manches Cooper Solicitors. The PMC legal team are available to answer your enquiries in every area of the law (employment to child protection). If your matter requires ongoing legal work, charges are made clear, with special reduced rates for ISA Members.

## IStip

As an ISA Member, your school is able to access the Independent Schools' Teacher Induction Panel (IStip) for statutory induction of NQTs. IStip is the single largest statutory body for induction, with over 1000 registered NQTs annually. (England only.)

## Competitions for Independent Schools

Each year the Whitbread and Lexden Prizes are awarded for outstanding performances at GCSE and A-level respectively, combined with exceptional service to the wider community.

The ISA Awards is an annual awards ceremony which recognises and celebrates success in the schools of our ISA Member heads. Now in its fifth year, the ISA Awards invites entries from schools of ISA Members in a range of categories, recognising achievement in academic and extra curricular provision and community and outreach activities.

## Sport

ISA Sport offers an extensive programme of Area and National events for our member schools to participate in throughout the year. ISA Sport has been a key feature of ISA since the Association was founded in 1878 and it is now one of the largest sports programmes offered to Independent schools in the UK. For many pupils, an ISA sports event is the first time that they get to represent their school or Area. This widens their horizons and provides greater challenge when compared to their everyday experiences. ISA provides sporting opportunities at all levels so that a large number of pupils can enjoy and benefit from them.

## Arts

Independent schools have long celebrated the value of the arts and ISA Arts are committed to continuing this with a growing programme of both in-person and virtual events, widening the access to extra-curricular opportunities that have now become a highlight in the calendars for many of our schools. We deliver events, competitions and challenges which give pupils the chance to express themselves, achieve awards, gain feedback from experts, attend and perform at live events and learn from the work of their peers. Inclusion is at the heart of ISA, there are opportunities for pupils from EYFS to Sixth Form.

## ISA Forum

ISA hosts an online Forum packed full of useful links and resources, encouraging discussion and debate between heads on a range of educational issues.





## Mentoring

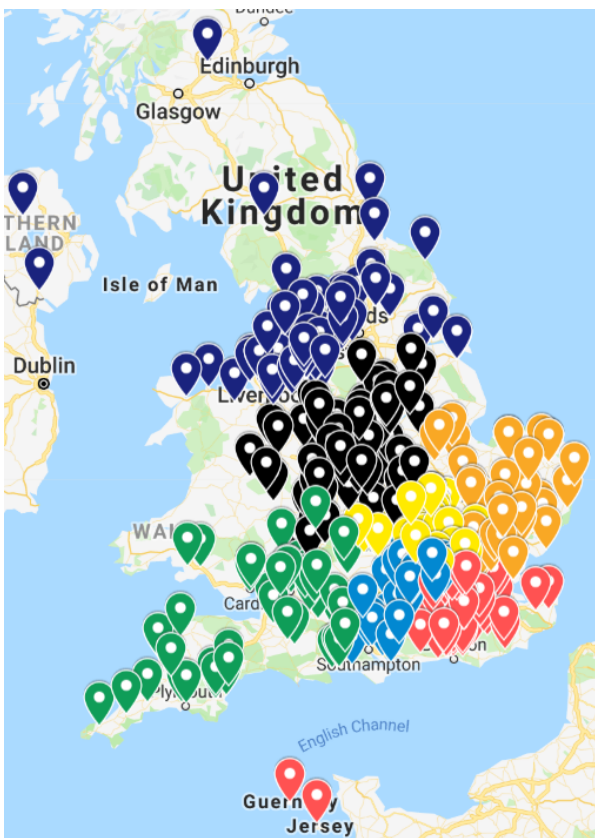
New Heads have the opportunity to be mentored by an experienced head for their first two years of headship, providing useful advice and support, as well as a friendly ear.

## ISA Regional Ambassadors

ISA Regional Ambassadors are an additional layer of support for Heads and their schools. All are experienced school leaders and are on hand to visit your school at short notice. Each ISA Member will receive a courtesy visit from their Regional Ambassador annually.

## Area opportunities

ISA consists of seven regional Areas. Each has an Area Coordinator who provides support and advice to new and existing Members. Each Area is run by a committee of dedicated ISA Heads and Principals, with a range of sports events, meetings and professional development opportunities on offer. Wherever your school is located, ISA is a close and supportive presence.



## Committee involvement

ISA run Subject Level Networking Groups available for staff within Member schools in a range of subjects. # Requirements for Membership

## Requirements for Full Membership

### **a. Candidates for Membership**

To be elected to Full Membership of the Association, Members (Heads/Principals/School Leaders) are required to:

- Be the person in day-to-day control of the school.
- Has sufficient relevant experience as agreed by Executive Council. Our Members do not have to hold a specific degree or qualification.
- The head is the member, not the school, and so there is no requirement for the school to be in the TPS.

### **b. Registration and inspection requirements**

All schools/colleges with more than 5 pupils of compulsory school age are required to be registered with the Department for Education as an independent school and to undergo a Government approved inspection, e.g. Ofsted or ISI. FE (Further Education) colleges with fewer than 5 pupils of compulsory school age may apply for full membership based upon a successful Educational Oversight Inspection.

To be elected to membership satisfactory inspection standards must be reached and maintained. Applicants for Full Membership submit a copy of their school's latest inspection report for consideration. This may be an ISI, Ofsted or other report from a recognised inspectorate. Where there are no significant regulatory failings and where inspection judgements meet the standards, schools will be eligible to be brought into membership.

For registered Independent schools, where significant regulatory failings exist and/or standards are below an acceptable level, the Association may defer membership until evidence of satisfactory regulatory compliance is available. While membership may not be possible at this juncture, ISA will advise and support the school until appropriate standards are reached and an application for membership can be resubmitted. No additional application charge is levied.

In cases of minor regulatory non-compliance, ISA may admit an applicant into membership though it may not be possible to move onto ISI's inspection regime until compliance is attained.

All members are required to send ISA any Ofsted or other public reports as soon as these are published.

### **c. Accreditation procedure**

The application procedure involves a number of stages.

- You complete and return the application form. On receipt of your paperwork, we will review the application and your last inspection report. A registration fee (see below) is payable at this point and ISA will invoice the school.
- Your papers will be sent to the appropriate ISA Area Coordinator. He/she will contact you to arrange to meet with you in your school/college. The purpose of this visit, which forms part of the accreditation process, is as much to ensure that you are aware of all that ISA has to offer as it is to see you at work in your own environment. This is of course NOT an inspection of the school and you will not be asked for evidence of compliance.

- Following their visit the Area Coordinator will write a report to be presented at the next meeting of the Membership Committee (these are held 3 times a year). The report will include a recommendation regarding suitability for ISA membership. ISA's Membership Committee will in turn make a recommendation to the Executive Council who will take the decision to move schools into full membership. If successful your school/college will have access to full ISA benefits. Your school/college will be presented with a plaque denoting full membership and you will be able to use the ISA logo. Your pupils will also be able to take part in all ISA activities from that point onwards. ISA will invoice you for the fees, as well as ISC fees (which ISA collects on ISC's behalf). We will notify ISI of your acceptance into membership and the inspectorate will then contact you and levy its fees accordingly.

The Membership Team will keep you abreast of developments throughout the process.

### Requirements for Dual Membership

The requirements are as above, but the Association recognises that you have already been accepted into membership of one of the other heads' associations within ISC. The process is more streamlined and you receive a reduction in ISA subscriptions to recognise your Dual Membership.

### Requirements for Affiliate Status (UK, Overseas and Group)

#### **a. Candidates for Membership**

Our Members (Heads/Principals/School Leaders) are required to be the person in day-to-day control of the school/college sufficient relevant experience as agreed by Executive

#### **b. The school/college must:**

- Be registered/certified as a bona fide school/college in the country concerned and be legally constituted in that country (documentary proof is required)
- Provide a curriculum taught in mainly or partly in English and based on a British Curriculum. For secondary schools, recognised British Examination Boards should be used
- Show through local inspection reports (as appropriate) and exam results that it is performing at an acceptable level of competence (where available a copy of the latest inspection report will be required)

#### **c. Accreditation**

Following receipt of the application pack, a review of the school's inspection report and where appropriate a visit to the school by an ISA Area Coordinator or other official (where applicable and practical), the Membership Committee considers the application. If the school meets the standards set, and shares the values of the Association, then accreditation will be approved.

**Requirements for Associate Status**  
**(including: Head/Principal of group, school,**  
**life and former member)**

Full/Dual Members may put forward members of their staff, who have management/ leadership responsibility, for school associate status. Alternatively, a person overseeing the running of a group of schools, where the Heads/Principals of the schools within the group are in full membership, may apply for associate status. Retiring Heads/Principals may apply for life associate status and finally, ex members and ex school associates who have not retired but who have moved to work in non ISA schools, may apply for former member associate status.

In each case, on return of the application paperwork the Membership Committee will take the decision to accredit the member. The Membership Team will keep the applicant and Head/Principal abreast of developments throughout the process



# Professional Guidance for Members

On joining the Association Members agree:

1. To abide by the terms of the Memorandum and Articles of Association \*(see ISA website) and Regulations as laid down occasionally by the Executive Council of the Association, and the ISA standards set out in this information
2. To attend the Heads' Induction Course within the first two years of becoming a Member
3. To encourage staff at all levels throughout the school to participate in ISA's range of courses and conferences, and INSET generally
4. To notify the Deputy CEO immediately of any fundamental change ("material change") to the school, such as age range, governance, change of Head/Principal/Proprietor and contact details. The Chief Executive Officer should be advised if the school is in difficulty, as help and guidance is available - but early action is imperative
5. To pay all fees required by the Association within the invoice period set
6. To abide by the letter and spirit of the Associations Code of Practice \*(see ISA website) which covers:
  - Provision of information
  - Relationships with parents
  - Relationships with other schools and organisations
  - Marketing
  - Staff
  - Admissions
  - Statistical information
  - Transfer
7. To make every reasonable effort to maintain accreditation standards, including compliance with the Independent Schools Standards Regulations and other regulatory requirements under relevant law pertinent to registered independent schools.

# ISA Fee Structure

Fees vary depending upon the type of membership. A registration fee of £455 is payable on receipt of an application. All ISA charges are reviewed annually in September. For 2024/25, ISA fees are:

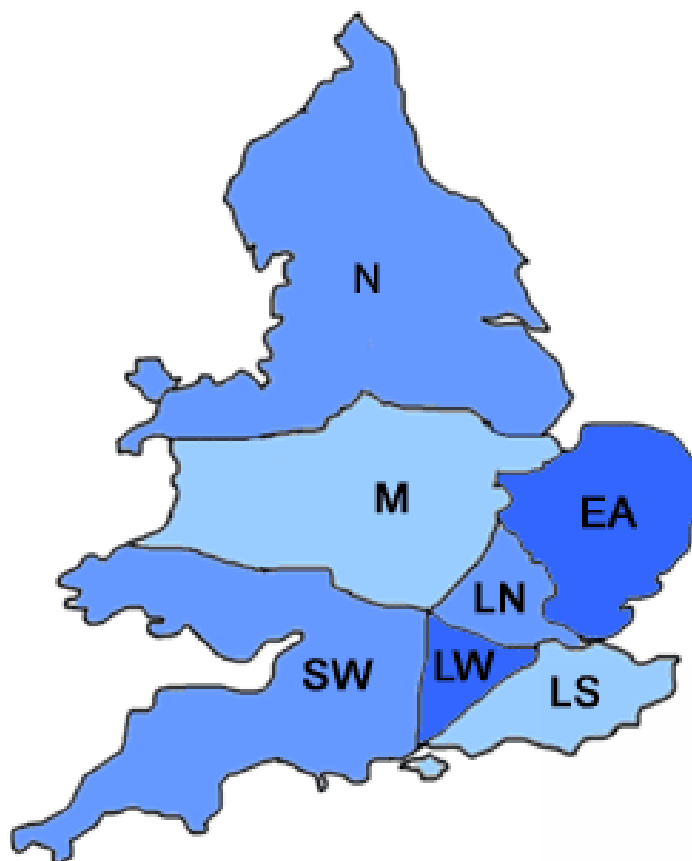

## Appendix 1

### ISA Enrichment: Sport (updated regularly on ISA website)

ISA runs an annual programme of sporting competitions at Area and National levels. The Sports Calendar details National-level events taking place this academic year. Each ISA area has a nominated Sports Co-ordinator who is also a member of our Sports Committee, which meets once a term. Our Members, pupils and parents all value highly the provision of sport in ISA, which enjoys a justifiably high reputation.



In 2024-25 ISA Sport plans to run over 60 national events, giving over 7000 children amazing sporting opportunities including football, hockey, table tennis, golf, sailing, judo and many more. Please see the [Sports Calendar](#) for a full list.



### ISA Enrichment: Fine Arts and Performing Arts (updated regularly on ISA website)

ISA Arts runs a number of prestigious annual regional and national events and competitions. There will be 24 National opportunities in 2024-2025 in a variety of disciplines and genres. The programme includes live events such as Dance, Drama, or Music Competitions. Virtual competitions and challenges are also available including Comic Strip, Poetry, Essay, STEAM, or Digital Art Competitions, which are easily accessible to schools across the country. Opportunities are open to a wide age range. Some competitions dedicated to EYFS and Primary pupils (such as Handwriting Competition) and some for older students (Debating and Public Speaking for example). We encourage everyone to participate, however large or small their school. Entry into ISA sporting and arts competitions is, however, restricted to ISA Full, Dual and UK Affiliate Member schools.

## Appendix 2

### Frequently asked questions.

- **Does my school need to be a member of the Teachers' Pension Scheme in order to qualify for membership?**

No – ISA does not require this of its schools or insist on a minimum pension contribution, beyond the arrangements required of all employers.

- **Does my school have to offer any specific pay scale or spine to qualify for membership?**

No – as with pensions, all ISA schools are free to make choices on pay and conditions in line with their wishes.

- **If I become an ISA Member, do I have to join any other organisation or be a member of a union?**

No – ISA members are of course free to join any other organisation as they see fit. Membership of a recognised headteachers' union such as ASCL or NAHT is always worth considering, but is not a requirement.

- **Do I have to attend national conferences or the Area meetings each year?**

We very much hope that you will attend our events, though none are a requirement beyond the Heads' Induction Course which new Members should attend sometime in their first two years of headship, no matter what their previous headship experience might be. The Association's Annual Conference is reserved for ISA Members and focusses on the fellowship and support that sustains leadership. The Autumn Study Conference in November is open to Members and their leadership teams, to share best practice and hear of the latest pedagogical developments. Area meetings are similarly encouraged, with most Areas holding termly meetings and an Area AGM.
